## **Labor Capital Strategies Internship Information Sheet**

### **Internship Description**

The Labor Capital Strategies (LCS) Internship matches undergraduate students with top labor groups and progressive investment groups advocating for working people. The LCS Internship provides an opportunity for students to observe the impact of finance and capital strategy, support efforts to strengthen the labor movement, and develop their own understanding and skillset.

The LCS Internship will:

- introduce students to key issues affecting workers and the labor movement;
- provide an experiential learning opportunity through the internship;
- develop students' understanding and research skills through hands-on work with dynamic organizations;
- and support the labor movement and economic justice.

Through their involvement in labor capital strategies organizations, students will develop their own view of the challenges facing workers in the modern economy and the role of worker justice. From these experiences, students contribute to the next generation of the worker justice movement.

The internship begins with a three day orientation in early June 2018, immediately followed by the beginning of the internship placement. The internship placement will conclude eight weeks later in late July 2018.

### *Benefits of the Internship*

The LCS Internship is a paid internship. The \$2,500 monthly stipend will be sufficient to cover housing, food, and living costs for the duration of the internship (\$5,000 total over the course of the internship's 8 weeks). The internship will not provide health benefits.

### *Internship Placement Organizations*

Students may indicate a preference for a particular placement organization, but this does not guarantee they will be assigned to their preferred placement (however, we will try to take preferences into account).

### *Program Oversight*

## **Eligibility and Requirements of the Program**

### *Academic status:*

Applicants must be currently enrolled in college.

### *Work Expectations:*

Generally interns will work for 40 total hours per week. Work on the weekend and evening work may be required. The work is highly dependent on the needs of each individual organization and final schedules will be set by each organization.

Students must be able to begin the program at the beginning of June 2018.

### *Final Report:*

At the end of the summer, all interns must submit a 1,000-word report on their experience with their organization, what they learned through the LSC Internship, and their strategy and vision for how they will apply the skills they've gained in the future.

### **Desired Skills/Qualifications**

The applicant should:

- have a strong interest in deepening their knowledge and understanding of social and economic justice and what this means for workers in the American economy;
- demonstrate an ability for research and an interest in learning about capital investments;
- be a team player who works well with others;
- be a self-starter who is motivated to tackle projects and the task at hand;
- bring energy, creativity, enthusiasm, and an open mind to the work.

Prior experience and familiarity with the history of the US labor movement is not necessary but will be considered as useful assets in favor of an applicant.

- Complete the application form
- Provide a one-page personal statement
- Provide two references
- Submit a resume
